Terms and Conditions

1. I declare and warrant that I am:
 - a. Between the ages of 5 and 25 as of July 1, 2008,
 - b. Not under contract for any entertainment related talent.
2. I agree to pay a Registration Fee of \$25 at the registration for the Open Audition before being allowed entry to sing/perform at the Open Audition event or at the Event finals.
3. Individual participation only. No duets or groups
4. Musical accompaniment can include:
 - a. Recorded music without any voice-over (bring your own)
 - b. Live music accompaniment by participant or separate (single instrument only)
5. Please provide a copy of recorded music to organizers in advance of performance to ensure the media is conforming to the equipment
6. Participants must perform. Lip-synching will lead to disqualification.
7. Changes to pre-selected songs will be accommodated until July 20, 12noon
8. No substitutes for participants will be permitted once the competition begins
9. No refunds
10. The winners (1st, 2nd, 3rd places) of the Goan Idol Singing Competition's Final Competition must agree to perform at the 2008 International Goan Convention, if called upon to do so.
11. I have read and agree to abide by the rules, regulations, terms and conditions of the Competition as revised from time to time by the Organizer and accept the decision of the Organizer as final and hereby acknowledge that the interests of the Competition shall override those of any Contestant.
12. I hereby assign irrevocably to the Organizer the entire copyright and all other rights to my audition, performance, and contribution to the Competition. The Organizer shall be entitled to use and exploit and license others to use and exploit such contribution, for the full term of copyright and thereafter insofar as is possible in perpetuity.
13. The Organizer shall be entitled to:
 - a. Change, add, or delete any parts of the Competition proceedings and formats.
 - b. Make and to authorize the making of any recording of my performance separately from or in conjunction with the Competition.
 - c. Include, or choose not to include, my name, likeness, voice, biographical details, photographs of me and recordings of interviews with me separately from or in conjunction with the Competition in all media and formats.
14. I acknowledge that no fees, royalties, or other consideration will be payable to me in respect of any broadcast, subsequent rebroadcast or any other use by the Organizer of the Competition in any manner or media format.
15. The Organizer shall not be liable to me or my legal representative for any loss or damage or injury to me or my property caused by or suffered during or in connection with my taking part in the Competition, including without limitation, as a result of personal injury, invasion of privacy, libel, defamation or infringement of copyright, unless caused by the negligence of the Organizer and recoverable on that ground following judgment of a competent court of final judgment.
16. The Organizer may assign my services and all other rights in my contribution to and participation in the Competition to any of its associated member organizations and to any other third party.
17. The Courts of Ontario shall have sole jurisdiction in relation to the terms and conditions of the agreement contained in this registration which shall be interpreted according to the laws of Ontario and the laws of Canada applicable therein, without regards to conflict of laws.
